7. After the deadline for entries on Tuesday 1 August at 23:59, photos will be added into a Facebook album.
- 8a. A voting process will begin on Wednesday 2 August to determine the final 50 winners. These will be selected by follower vote from all valid entries submitted on the Facebook post before the deadline of Tuesday 1 August at 23:59.
- 8b. During the voting process, one like will count as one vote.
